Curriculum/Academics/Data

- Check-Ins
 - 4th-8th grade classes took the Check-In 1 assessment between January 30th-February 2nd. Results are below- may change slightly after make-ups.

4th Grade Reading 66%
4th Grade Math 50%
5th Grade Reading 55%
5th Grade Math 74%
5th Grade Science 43%
6th Grade Reading 31%
6th Grade Math 33%

- Plans in place to foster growth and higher levels of proficiency
 - Tutors: two tutors are continuing to meet with 4th, 5th, and 6th graders daily using standards-based resources provided by their teachers. The groups of students who are meeting with these tutors are also selected by their teacher based on data from EVAAS, iReady, Check-Ins, and quiz/test grades.
 - 4th graders attend math and reading groups, 5th graders attend reading groups, and 6th graders attend math groups.
 - Most importantly, these groups of students are fluid. Once students show mastery,

they exit the tutor program and new students are selected.

- iLEADR: iLEADR has provided more professional development to our K-5 teachers as well as our middle school teachers. Their focus has been on raising the ceiling for high performing students in order to help them grow.
- Data Discussion Meetings
 - Ms. McGinnis and I are continuing to meet with 3rd-8th grade tested area teachers to analyze data and provide resources that help them scaffold their instruction.

Professional Development:

- Teachers will receive further training from iLEADR on Thursday, February 15th. ○ An iLEADR representative will be modeling in reading and math classrooms what was covered in our most recent PD session: how to raise the ceiling for high performing students.
- On Thursday, February 8th, we will have our fourth Data Discussion Meeting of the year with 3rd-8th grade reading and math teachers. This meeting will focus on data from our 2nd Check-In.
 - Teachers will use their data to determine next steps that will yield the most results in student proficiency and growth.
- Ms. McGinnis and I will be attending a Teach Like a Champion workshop on March 14th and 15th. The purpose of the workshop is to train us on seven high-impact, high academic expectation techniques from Teach Like A Champion 3.0. This collection of techniques will help us coach our teachers to positively engage students in rigorous academic work. We are excited for the opportunity to provide our teachers with effective strategies that support PCA's high expectations.

Beginning Teacher/New Hires:

- During the month of February beginning teachers will engage in peer observations. This is an opportunity for an experienced peer teacher to formally observe them and provide helpful feedback. All peer observations will be completed and turned in by the end of the month.

Action Item:

- We are seeking approval of the Summer Program Plan as presented by Miss Candice Frazier in the attached report.

Curriculum and Academics:

- The curriculum committee has met and the master schedule for next year is well on its way. There will be a few changes for the 2024-25 school year. Some of these are due to the department of public instruction changing the graduation credits. PCA will be offering a computer science course as well as an arts course in 8th grade that will meet these new graduation requirements. This will also change the format of our 7th and 8th grade interdisciplinary classes to semester courses. In addition, the plan is to offer a robotics course as an elective as well as an internship course. The internship course is in its beginning stages but we are hopeful to be able to offer at least one section in the 2024-25 school year.
- The high school team has several field trips coming up in the next few weeks. The 9th grade students will be attending a trip to Asheville on Wednesday, Feb. 14th to view the beautiful Biltmore House and Estate. Classical Foundations Program (CFP) Update

February 5, 2024

1. The Foundation for Economics Education has arranged for Howard Beatty to be our spring Classical Foundations Program on March 26. His biography:

Mr. Beatty graduated from the University of Michigan with Bachelor's and Master's degrees in Chemical Engineering and from the University of Chicago with an MBA.

During his lengthy career with BP (Amoco), he led teams in production and supply chain optimization, major capital investment evaluations and large scale project management. He has been a Junior Achievement volunteer for over 15 years teaching principles of business, economics and ethics to grade school, middle school and high school students. He is a member of the Foundation for Economic Education (FEE) Faculty Network.

Mr. Beatty strongly believes in the founding principles of the United States Declaration of Independence and Constitution coupled with free market capitalism as the best way for humans to prosper and reach their highest potential.

2. Dr. Christine Basil Boor has agreed to be our commencement speaker on Saturday, June 1, 2024 (the Saturday after Memorial Day). Dr. Boor received her Ph.D. from Baylor University and teaches in the Honors College at Belmont Abbey College. She teaches courses in Aristotle's *Ethics* and *Politics*, Greek history, the trivium (grammar, logic, and rhetoric), and political thought.

3. Hadley Heath Manning, a Shelby native, has agreed to be our commencement speaker on Saturday, May 31, 2025 (the Saturday after Memorial Day). Her biography:

Hadley Heath Manning is vice president for policy at Independent Women's Forum and Independent Women's Voice and a Senior Blankley Fellow at the Steamboat Institute.

Hadley has testified before Congress and state legislatures on various policy issues. She also appears frequently in radio and TV outlets across the country and is a regular guest on the Fox Business Network. Her work has been featured in publications such as the Wall Street Journal, Forbes, POLITICO, and many others.

In 2016, Hadley was named to Forbes' 30 Under 30 list in Law and Policy.

Hadley graduated with distinction from the University of North Carolina as a Morehead-Cain Scholar with a double major in economics and journalism. She now lives in Denver, Colorado, with her husband and children.

During its February 2 meeting, the Classical Foundations Program advisory board approved the following changes to its governance document (also appended for reference):

- p. 2 (membership): change “and the board will elect a chairman to a one-year term during the summer meeting” to “and the board will elect a chairman **and vice chairman** to a one-year term during the summer meeting”
- p. 2 (faculty liaison): change “serve as an ex-officio member” to “serve as a **non-voting** ex-officio member”

Minutes of November 3, 2023 meeting

The Pinnacle Classical Academy Classical Foundations Program advisory board met virtually on November 3, 2023, at 4:00 P.M. Eastern time. Wes Westmoreland (chair), Marianna Davidovich, Rachel Humphries, David Raney, Thomas Pack, Adam C. Smith, and Jeff Ziegler were in attendance. Anna Steinberg was absent because of an emergency.

With the agenda approved without objection, and the minutes of the July 21, 2023, meeting approved without objection, Sen. Westmoreland and Mr. Ziegler offered an update on the progress of Pinnacle Classical Academy and the Classical Foundations Program. Items discussed included state testing data, construction progress, the CFP section of the new library, the future amendment of bylaws, and placement on *U.S. News & World Report's* lists as one of America's best elementary schools, middle schools, and high schools.

During the discussion that ensued, board members suggested that Pinnacle Classical Academy tag CFP board members on its LinkedIn posts – an idea welcomed by Mr. Ziegler

Mr. Ziegler then offered an update on CFP fall lecture, spring lecture, and graduation speaker, as well as upcoming school events (Veterans Day and Homecoming).

Without objection, the meeting adjourned at 4:40 P.M.

Classical Foundations Program

(as approved on August 12, 2020)

Mission

The mission of the Classical Foundations Program at Pinnacle Classical Academy is to provide students, faculty, and community leaders with a deeper understanding of the nation's founding principles and their application to modern life and society through historical and economic works that are part of the school's curriculum and through a series of academic events.

Values

At Pinnacle Classical Academy, our values enable us to achieve our mission and purpose. Our ten values, portrayed on the class ring, are ultimately derived from Aristotle's *Ethics*, are consistent with one another, and are integrated into a sound framework of staff and student **Character** (honesty, integrity), **Judgment** (reality, reason, independent thought), **Success** (productivity, teamwork, justice) and **Happiness** (self-esteem, pride). Our focus on values grows from our belief that ideas matter and that an individual's character is of critical significance. Our commitment to these values is also manifest in our Lyceum, which takes its name from Aristotle's school in Athens.

Pinnacle Classical Academy Education Foundation

The Classical Foundations Program will work under the umbrella of the Pinnacle Classical Academy Education Foundation and will function within the meaning of Section 55A-1-40(4) of the North Carolina General Statutes and for charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1954. The Classical Foundations Program will have an independent board to oversee the program as outlined below.

Classical Foundations Advisory Board

An advisory board is established and maintained to review, approve, assess programs and add programs, to offer counsel on fundraising, and to ensure the intellectual honesty of the program, built on America's founding principles and Pinnacle Classical Academy's values.

Membership

The board shall include as few as six, or as many as 12 members made up of

members recommended by various organizations including but not limited to Foundation for Economic Education (FEE), the Classical Liberals in the Carolinas (CLC), Hillsdale College, Ayn Rand Institute (ARI), Intercollegiate Studies Institute (ISI), or other philosophically similar organizations, and shall always include one member identified by the Pinnacle Classical Academy board chair. These will serve until their replacement is named. The Classical Foundations Program board must approve any new member unanimously, and the board will elect a chairman to a one-year term during the summer meeting.

Classical Foundations Faculty Liaison

A Pinnacle Classical Academy faculty member, approved by the Classical Foundations Program board, will oversee the operational aspects of the program, serve as an ex-officio member, act as secretary, and receive additional time within his workday each semester in which to focus on the Program.

Meetings

Meetings will be held at least twice each year and may be conducted by voice or video conference. The Classical Foundations Faculty Liaison will be responsible for planning, scheduling and coordinating all Program activities within the regular school calendar. The outline of programs for the upcoming year, along with a budget, must be approved by the Classical Foundations Program board and presented to the Pinnacle Classical Academy board prior to the start of the school year, but can be amended as necessary by the faculty liaison or the Classical Foundations Program chairman by sending notice to the Classical Foundations Program Board.

Finance

Pinnacle Classical Academy Education Foundation shall receive and hold Classical Foundation Program monies and shall disperse upon the request of the Classical Foundations Board chairman or secretary. Expenses will be communicated by email or in writing to the Classical Foundation Program board by the Classical Foundations Program chair or secretary prior to each meeting.

PCAEF shall provide a complete accounting of monies of the CFP to the CFP board prior to biannual meetings, and shall report CFP income and expenditures at least annually to the Foundation board and PCA board.

Termination

Should the Classical Foundations Program cease to exist, all monies in this program shall be donated to philosophically similar organization(s) as determined by the Classical Foundations Program board, specifically for use in similar high school education efforts.
